ENGINEER'S STATEMENT

This Report is prepared and submitted, as directed by the Board of Directors, pursuant to the Municipal Improvement Act of 1913 and the resolution of intention adopted by the Board of Directors, as supplemented by Article XIID of the California Constitution and Sections 53570 and following of the Government Code.

The Improvements which are subject of this report are briefly described as follows:

The work to be done may consist of constructing water treatment plant expansion, storage tanks, water distribution, wastewater system upgrades, and all other work and appurtenances necessary to complete the water and wastewater improvement system to benefit the parcels in the proposed assessment district.

A USDA loan, representing unpaid assessments, and bearing interest at a rate not to exceed four percent (4.0%) per annum for a forty (40) year term, shall be issued to fund said water and wastewater improvement project.

This report includes the following attached exhibits:

EXHIBIT A: Description of the project.

EXHIBIT B: The estimate of the project cost.

EXHIBIT C: An assessment roll, showing the amount proposed to be specially assessed against each parcel of real property within this assessment district.

EXHIBIT D: A statement of the method by which the undersigned determined the amount proposed to be assessed against each parcel, based on benefits to be derived by each parcel, respectively, from the program to be funded.

EXHIBIT E: A list of the names and addresses of the owners of real property within this assessment district.

EXHIBIT F: An assessment diagram, showing all of the parcels of real property to be assessed within this assessment district. The parcels are identified by assessment number, keyed to Exhibit C.

EXHIBIT A: PROJECT DESCRIPTION; PLANS AND SPECIFICATIONS

The project to be financed by this Assessment District (the "Improvements") will generally consist of the construction and acquisition of the following public improvements, including the acquisition of all lands, easements, rights-of-way, licenses, franchises, rights of service and use, and permits and the construction of all auxiliary work necessary and/or convenient to the accomplishment thereof in accordance with plans and specifications to be approved by the Circle Oaks County Water District:

Water System Improvements: The water system improvements will include new or improved storage tanks, treatment plant expansion (including a new office), distribution lines, and new fire plugs with fire hydrants.

Sewer System Improvements: The wastewater system improvements will include replacing sewer pipes and mains and installing a SCADA system for the sewer plant.

The Circle Oaks County Water District (District) provides water and wastewater treatment to the Circle Oaks community of Napa County. At buildout the District will service approximately 350 parcels. In 2000, the District imposed a building moratorium that has since been lifted. Currently, the District is servicing approximately 187 parcels.

The District's water and wastewater systems were originally designed to accommodate full build-out of the service area. A number of the components that comprise the systems are at or beyond their useful life. This situation threatens the District's ability to provide reliable service in accordance with applicable State regulations, and to maintain its obligation to serve the entire constituency.

Presently only one of the District's three original wells is usable. The District therefore relies on treated surface water derived from springs to satisfy water demands during peak usage periods. The surface water treatment facility must be operated continuously during the summer to accommodate demands. As a result the facility cannot be taken off-line for maintenance or repair during this period. The proposed project adds a second treatment unit and related facilities to provide the redundancy and operational flexibility that is both desirable and recommended by the California Department of Public Health. Two of the District's original redwood water tanks need to be replaced due to their deteriorated condition. Their condition and lack of modern seismic restraint makes them vulnerable to sudden and catastrophic failure. The District intends to replace the tanks with three new tanks designed and constructed in accordance with the current building code. The replacement tanks have a combined greater capacity than the original tanks to enhance both system reliability and fire protection. Also, the fire protection capability of the distribution system will be further enhanced by the installation of fire hydrants to replace existing smaller diameter standpipes.

In addition to the water system improvements, the District will also make repairs to a portion of the wastewater system. Portions of the sewer collection system are prone to inflow and infiltration due to mainline and lateral breaks. The excessive inflow and infiltration stresses the wastewater system to the point where there is a risk of a discharge violation and utilizes capacity in the treatment facilities that should otherwise be available for existing and future customers. The District intends to replace the most problematic a portion of the collection system to reduce system inflow and infiltration.

For a complete description of Improvements, please refer to "Alternative 2 of the Upgrades Project" as described on Page 3 of the Utility System Upgrades memorandum dated July 29, 2009 by Brelje & Race, the first three pages being attached hereto as Exhibit I.

Reference is hereby made to the plans and specifications for the Improvements and these assessment proceedings on file in the office of the District General Manager, which are incorporated into this Engineer's Report by reference.

EXHIBIT D: METHOD OF APPORTIONMENT

General

Proposition 218 requires that the District levy assessments according to the special benefit each parcel receives from the Improvements (or activities to be funded by the Assessment District). Proposition 218 added to the state constitution Article XIIIID Section 4(a) which states in part:

"The proportionate special benefit derived by each identified parcel shall be determined in relationship to the entirety of the capital cost of a public improvement...No assessment shall be imposed on any parcel which exceeds the reasonable cost of the proportional special benefit conferred on that parcel... Parcels within a district that are owned or used by any agency, the State of California or the United States shall not be exempt from assessment unless the agency can demonstrate by clear and convincing evidence that those publicly owned parcels in fact receive no special benefit."

Determining the proportionate share of special benefit among the parcels of real property within the proposed assessment district which benefit from the proposed activities is the result of a four step process: 1) defining the proposed Improvements; 2) identifying how each parcel specially benefits from the proposed Improvements; 3) determining the amount of the special benefit each parcel receives from the proposed Improvements; and 4) apportioning the cost of the proposed activities to each parcel based on the special benefit that each parcel receives from the proposed Improvements.

Special Benefit

The Assessment District is being formed, and the Assessments will be levied, under the Act and Article XIII D of the California Constitution, which require that only special benefits may be assessed, and that a parcel's assessment may not exceed the reasonable cost of the proportional special benefit conferred on that parcel. The law does not specify a method to use when determining the amount of special benefit to each parcel. The Engineer of Work is responsible for conducting the benefit analysis and then making a recommendation to the Board of Directors, who then makes the final determination. Therefore, the assessments within this report have been apportioned by the Engineer of Work in accordance to the proportionate special benefits received by the lots and parcels of land within the Assessment District. The Assessment apportioned to each lot represents its prorated share of the total estimated capital cost of the Improvements. No assessment has been apportioned on any parcel that exceeds the reasonable cost of the proportional special benefit provided to that parcel.

The State Constitution Article XIIIID requires that assessments be levied according to the special benefit each assessed parcel receives from the Improvements. The Improvements provide a special benefit to all assessed parcels. The special benefit to parcels from the proposed Improvements exceeds the total amount of the proposed assessment.

The Improvements are provided only within the boundaries of the Assessment District and provide no special benefit to the properties outside the Assessment District boundaries. The special benefit must affect the assessed property in a way that is particular and distinct from its effect on other parcels and that real property in general and the public at large do not share. A general benefit is defined as a benefit to properties in the Assessment District and in the surrounding community or benefit to the public in general resulting from the Improvements to be provided by the assessments. Inasmuch as the Improvements will be provided to the properties within the Assessment District boundaries and will not serve any parcels outside of the Assessment District boundaries, there are no general benefits, or if there are general benefits, they are insubstantial and not quantifiable.

It has been determined that the proposed Improvements will provide the same special benefit to all parcels being assessed. Each assessed parcel will receive equal benefit from the proposed Improvements as the work involves repairs, replacement and reliability enhancements to the water and wastewater systems from which each assessed parcel has equal rights to access and utilize. The proposed Improvements are intended to allow the District to maintain the ability to provide these services to all developed or developable parcels within its service area and to provide reliability enhancements that are designed to ensure utility operations consistent with applicable local and State regulations. Therefore, every assessed parcel in the Assessment District will benefit equally from the proposed Improvements.

Assessment Methodology

There are 356 parcels in the Assessment District, of which, 339 parcels are developed or developable. The other 17 parcels listed below are either open space parcels or owned by the Homeowners Association, County or the District as future tank sites and will not be developed or tie into the existing water and wastewater system. Of these 17 parcels, 10 are owned by either the Circle Oaks Homes Association or Napa County and are the open space parcels that surround the majority of the 339 residential parcels. The other 7 parcels are owned by the District and are used for existing and future tank sites. Therefore, since these 17 parcels are not developable and will not receive benefit from the proposed Improvements they will not be assessed. If, however, in the future the current development restrictions on any of these 17 parcels changes and any of the parcels develop, it will be subject to a connection fee the equivalent of the assessment rate at the time the Assessment District was formed.

Assessment Calculation

As previously discussed, each developed and developable parcel benefits equally from the proposed Improvements. Therefore each assessed parcel will be apportioned an equal share of the Improvement costs. To calculate each parcel's assessment is to take the total Improvement cost and divide it by the number of assessable parcels in the District, 339. Therefore, each parcel's assessment is \$10,539.82 (\$3,573,000 divided by 339).

EXHIBIT F: ASSESSMENT DIAGRAM

An Assessment Diagram of the Assessment District is attached and on file in the office of the Clerk of the Board, Circle Oaks County Water District. The lines and dimensions of each lot or parcel within the Assessment District are those lines and dimensions shown on the maps of the Assessor of the County of Napa, for the year when this Report was prepared, and are incorporated by reference herein and made part of this Report. The Assessor's maps shall govern for all details concerning the lines and dimensions of such lots or parcels.

EXHIBIT G: ASSESSED VALUATION

Pursuant to Sections 2960 and 2961 of the Streets and Highways Code, the County Assessor has stated that the assessed value (land plus improvements) for all parcels being assessed within the assessment district, as shown on the equalized tax roll of the County of Napa, is \$62,011,236, see letter from the Napa County Assessor on file with the Clerk of the Board. Furthermore, there are no existing unpaid assessments against any of the parcels being assessed within the assessment district. On this basis, the condition specified by Section 2961, which is that the sum of (a) the principal amount of all existing unpaid assessments, and (b) the principal amount of the proposed assessments of this assessment district shall not exceed one-half of the total true value of the parcels proposed to be assessed in this assessment district, is satisfied.

EXHIBIT H: ANNUAL ADMINISTRATION COSTS

As provided in Streets and Highways Code Section 10204(f), an additional assessment will be levied annually on each parcel within the Assessment District to pay costs associated with the administration of the Assessment District and the funding of a debt service reserve.

These annual assessments are separate from, and in addition to, (a) the per-parcel collection fee that may be added to each annual assessment under Streets and Highways Code Sections 8682 (to cover expenses of collection) and 8682.1 (to cover bond administration costs), and (b) any fees payable to the District in connection with Assessment pre-payments after the issuance of Bonds, apportionment of Assessments to reflect parcels splits or parcel mergers, and late charges and penalties for delinquent Assessment installments.

Each parcel within the Assessment District shall be allocated an equal share of these annual costs. The exact amount of these charges will be established each year by the District, and will consist of the following maximum amounts:

1. An annual amount to pay costs incurred by the District with respect to the administration of the Assessment District and the bonds that are not otherwise reimbursed, which will initially equal 2.0% of the annual installment of principal and interest payable on the assessment, and which will be adjusted annually by the changes in the U.S. Department of Labor Consumer Price Index for the San Francisco-Oakland-San Jose Area index.
2. If and to the extent required by any purchaser or underwriter of the bonds, an annual contribution (the "Debt Service Reserve Assessment") to a debt service reserve fund for the bonds, which will equal 10% of the annual installment of principal and interest payable on the assessment. The District shall discontinue levying the Debt Service Reserve Assessment when the amount on deposit in the debt service reserve fund equals the least of (a) 10% of the original principal amount of the bonds, (b) 125% of average annual debt service on the bonds, or (c) maximum annual debt service on the bonds; provided, however, that the District is authorized to resume levying the Debt Service Reserve Assessment as needed to generate any funds that may be required to replenish the reserve fund following the withdrawal of funds therefrom or if the District determines that a deficiency exists therein.
